**ADVERTISEMENT FOR APPOINTMENT/ ENGAGEMENT OF SPECIAL  
PUBLIC PROSECTOR IN CBI, EOB, MUMBAI TO CONDUCT CBI CAES IN  
TRIAL COURTS-REGARDING.**

1. CBI, EOB, Mumbai intends to create a panel of advocates for CBI, EOB, Mumbai Branch to undertake speedy and smooth trial of cases of CBI EOB Mumbai branch spread over multiple States / Districts, which cannot be attended to by the Prosecutors of the Branch. In this regard, applications are invited from the eligible advocates for engagements of Special Public Prosecutor in CBI to conduct trial of CBI cases in CBI Courts located at Mumbai, Kalyan, Thane, Pune and Nagpur.
2. **PROFESSIONAL FEE-** The Professional fees of the Advocates will be governed by the terms & conditions contained in DoPT ID No. 225/19/2023-AVD-II dated 08.04.2024 (copy attached).
3. **ELGIBILITY CRITERIA-** The following eligibility criteria may be considered carefully by the applicant while submitting the application for the appointment/ engagement of CBI Special Public Prosecutors to conduct trial of CBI cases before the CBI Courts at Mumbai, Kalyan, Thane, Pune and Nagpur.
  - i. Educational Qualification of LLB
  - ii. Enrollment Certificate as an Advocate with the Bar Council.
  - iii. Experience at BAR of handling criminal matters in Sessions Courts.
  - iv. An unconditional willingness/ consent to work on the general terms & conditions approved by Government of India from time to time.
  - v. A minimum standing of 10 years as an Advocate with experience in handling criminal matters.
4. **ENGAGEMENT PERIOD-** 3 years.
5. **NATURE OF JOB-** To conduct trial of CBI cases pending under trial and conducting of Appeals and Revisions in CBI courts and appellate courts located at Mumbai.
6. **DOCUMENTS TO BE SUBMITTED ALONGWITH THE APPLICATION-** These following documents are required to be submitted along with the application:
  - i. Copies of Educational Qualifications

- ii. Copy of Enrollment Certificates as an Advocate with the Bar Council.
  - iii. Experience at BAR of handling criminal matters in Sessions Courts.
  - iv. An unconditional willingness/ consent to work on the general terms & conditions approved by Government of India.
  - v. List of important cases handled by the applicant advocate.

Incomplete applications and applications submitted offline shall not be considered. Further, no applications shall be entertained by CBI, which are submitted after last date of submission of application. It may be noted that after scrutiny of applications, suitable candidates may be called for interaction/ interview at CBI Office, Mumbai.
